GUIDELINES FOR ALL PARTICIPANTS

To counteract and minimize diffusion of the Virus COVID19

- Registration: inside the shooting range (see enclosed map);
- Antigen test: antigen test station provided by the Health Agency of South Tyrol, testing will be effected in a tent outside the shooting range (see enclosed map);
- Target Sprint range: every Team will receive a space at it's disposal to be used as storage place for any material or as meeting point etc.
- Target Sprint range: the coaching zone are splitted in more areas that will be at every Team's disposal;
- Start Zone separated from Finish zone

Arrival in Italy:

For arrival in the territory of Italy please consider the prescriptions valid at the moment when the real arrival in Italy will occur.

To enter the Italian territory every person has to have a negative test, either antigen or PCR not older than 48h. At the moment when the present document is being done, no period of quarantine is foreseen when entering Italy.

Competition field:

Registration:

At the moment of registration (located in the shooting range office) the access is only allowed to max. 1 person for each Team and this person has to effect the registration of the whole team. The access is allowed only by wearing FFP2 protection and hand disinfection at the entrance. The registration personnel also has to wear FFP2 protection masks. During registration, every Team has to provide the results of antigen tests / PCR tests done before departure by every member of the team (athletes, coaches, companions, officials,...) with negative response (antigen test / PCR test not older than 48h), signed by a medical professional. In case that someone does not provide the requested document, the registration cannot be done and has to be disqualified (if it is an athlete) and no access admission in the competition field (all other members of the team). During registration all members of the team have to wait in the area in front of the shooting range so to ensure not to get in touch with other teams/nations.

Antigen test (done one time immediately after registration and valid for 72h):

After registration all members of the team have to effect the (rapid) antigen test, that will be provided by personnel of the Health Agency of South Tyrol in a tent in front of the registration zone. The access to the tent is admitted only with FFP2 protection mask and hand disinfection. After the test, a sheet with the result of the test will be handed out. If the test is negative, the access to the Target Sprint range will be allowed. In case of positive test, the person has to be isolated in a separate tent for PCR test. In case of confirmed positive test, the procedure will be decided by the Health Agency.

Access to competition range for free training purpose:

The access to the competition range is only allowed if a negative antigen test result made by the Health Agency of South Tyrol is provided when entering the Target Sprint range. Inside the competition range a special area will be assigned to every Team for the material necessary for shooting activity. Every Team will receive shooting positions at the shooting range and a certain time for free training at the running course. After the training, Teams must leave the range with respect to the distancing regulations. At every time, except during the training (running and shooting) the FFP2 masks have to be weared.

Between one training set and the next one, the shooting area will be purified.

Access to the competition range for competition purpose:

The access to the competition range is only allowed if a negative antigen test result made by the Health Agency of South Tyrol is provided when entering the Target Sprint range. Inside the competition range a special area will be assigned to every Team for the material necessary for shooting activity. The access to the competition range is allowed for the participating athletes in each turn only 5 min. before the start of the preparation for the competition and to the technical staff (max. 2 persons for each Team) in the "Coaching zone". After the competition, athletes must leave the range with respect to the distancing regulations. At every time, except during the training (running and shooting) the FFP2 masks have to be weared.

Between one training set and the next one, the shooting area will be purified.

General:


- At every time, except the competing athletes, the FFP2 masks have to be beare;
- It is not allowed to use the showers;
- During the checks of the guns, before or after the competition, the participant as well as the operators have to wear FFP2 protection masks, to disinfect the hands and the guns being checked;
- When a person uses the toilet a FFP2 mask has to be weared, hands must be disinfected before entering the toilet and when leaving the toilet. The toilets are situated inside the dressing rooms as indicated in the enclosed map;
- Every day there will be checks of all people entering the competition range. The check consists in body temperature measurement and check of all antigen tests with negative response. Only athletes, coaches, companions, officials and working personnel with these certifications and without symptoms of eventual infections will be admitted to the competition area;
- No public is admitted;

For everything not indicated in this document, the valid regulations are the ones included in the <u>PROTOCOL DATED MAY 30</u> as well as the <u>ADDENDUM FOR SPORT COMPETITIONS</u> <u>DATED JUNE 30, 2020.</u>
